RESOLUTION NO. 07-21

A RESOLUTION AMENDING RESOLUTION NO. 06-21, OF THE TOWN OF AVOCA, IN PART, AND REPEALING ALL OTHER RESOLUTIONS AND AGREEMENTS IN CONFLICT HEREIN; AUTHORIZING THE MAYOR TO PRESERVE AND REBUILD THE VETERAN MEMORIAL MONUMENT ESTABLISHED AND EXISTING AT THE TOWN HALL FOR THE TOWN OF AVOCA, ARKANSAS

WHEREAS, the Town of Avoca, Arkansas has built and maintains a Veteran Memorial Monument at the entrance to the Town Hall in Avoca Arkansas; and

WHEREAS, this Veteran Memorial is an important part of the Town's history and commitment to support and acknowledge the ultimate sacrifices of those having served proudly in our United States Military; and

WHEREAS, the current Veteran Memorial is in need of repairs and renovations to continue to support and acknowledge the ultimate sacrifices of those having served proudly in our United States Military; and

WHEREAS, such repair and renovations shall be done in a manner respectful of the current Veteran Memorial but in a manner that will enhance, update, repair and renovate the Veteran Memorial; and

WHEREAS, such repairs and renovations shall not in any way be considered a desecration, destruction or dishonor of the Veteran Memorial.

NOW THEREFORE, BE IT RESOLVED by the Town Council of the Town of Avoca, Arkansas:

Section 1: That pursuant to the previous vote of the Town Council of the Town of Avoca, Arkansas, the Mayor is authorized and directed to direct and oversee the repairs and renovations of the Veteran Memorial keeping tight to the need to enhance, update, repair and renovate the Veteran Memorial in a somber and appropriate manner, reflecting the honor to be given to those having served proudly in our United States Military.


Section 2: That such repairs and renovations shall not in any way be considered a desecration, destruction or dishonor of the Veteran Memorial.

Section 3: That the Mayor is authorized as desired to seek consultation of Military experts or past or present members of the Military to carry out this task as the Mayor determines is appropriate.
