8. Election Filing - Rec/Tres. Barnes reminded council members that Friday, August 17th at noon is the deadline for filing.

1. Planning commission - Ald. King

a. The Zoning Book is being cleaned up and will be presented to council for approval when finished per Ald. King.

- b. Ald. King informed council, Zoning official Larry Parrish, Rec/Tres. Barnes and himself met with town attorney McClure concerning the Ruiz property on Tucks Chapel Road. Attorney McClure informed council it was decided to fine Mr. Ruiz \$1000.00 (\$500.00 per offense) for being out of compliance and a letter was sent to Blue & Associates to inform them. This fine will need to be paid and a building permit will need to be obtained. They were also informed, before the lot split can me approved, they need to show the 2 lots can perk.
- 2. Board of Zoning Adjustments-Ald. King
 - a. Meeting was held July 17th after the Planning meeting per Ald. King no new business.

- 4. Streets Ald. Whitehorn
