Staff Report – Rec/Tres. Barnes

1. Avoca Fire & Rescue

May was a record setting for Avoca.

We ran a total of 77 calls. This brings us to 276 calls on the year so far!

45% of our calls came in from 8-5 when we have someone on duty. Our average response time is 8 minutes and 39 seconds.

The 2 structure fire calls, the first arriving unit was on scene in 5 minutes.

The 2 boat fires we had our fire boat launch and on scene in 16 minutes.

We added 2 new members onto the department. 10 members took Core Rescue class and we logged 258 hours of training.

5. Grants - Ald. Rairdon

a. Generator; Rec/Tres. Barnes states ER*Assist is helping the town get a Hazard Mitigation Grant for a generator for the Town Hall Building. The total amount is \$53,556.59 (fifty-three thousand, five hundred, fifty-six dollars and fifty-nine cents) with the town portion being, \$13,389.15 (thirteen thousand, three hundred, eighty-nine dollars and fifteen cents. Ald. Hansen made a motion to approve the towns portion of \$13,389.15 (thirteen thousand, three hundred, eighty-nine dollars and fifteen cents) for a generator for the Town Hall Building. Seconded by Ald. King. Discussion: none. Roll call: Ald. King: yes, Ald. Hansen: yes, Ald. Rollins: yes, and Ald. Alvarenga: yes. All Approved. Motion carried.

6. ARPA Funds (American Rescue Plan) - Ald. Rollins

a. Ald. Rollins, states she has no updates at this time. Fire Chief Elliott, asked the council if the \$10, 000.00 (ten thousand dollars) that was appropriated for air packs for the fire dept, be redirected for bunker gear? He states the Fire Dept is receiving money for air packs and the bunker gear is what they are most in need of. Ald. Alvarenga made a motion to reappropriate the \$10,000.00 (ten thousand dollars) from air packs to bunker gear for the Avoca Fire & Rescue Department. Seconded by Ald. King. Discussion: none. Roll call: Ald. King: yes, Ald. Hansen: yes, Ald. Rollins: yes, and Ald. Alvarenga: yes. All Approved. Motion carried.
