  - 1. The town issue dog licenses per dog per owner for a fee that will be waved if the dog owner can show the dog has been fixed.
  - 2. Any breeder must have a breeder license
  - 3. Unannounced inspections to all dog breeders
  - 4. Abandoned Property law
  - 5. Have a rabies clinic one Saturday a month
  - 6. No pet store ordinance

Attorney McClure will start working on some of these recommendations, and will be in contact with Mayor Whitehorn and Rec/Tres. Barnes.

d. Apple Shed Award: the council picked the 2023 recipients to be awarded the Apple Shed Award.
