a. Chief Oldebeken states the Avoca Fire & Rescue ran a total of 35 calls for June, and 285 for the year. \*\*\*No other information was provided.

Chief Oldebeken wanted the council to know, he believed it was a waste of his time and there was no value in him having to come to these council meetings, just to read off a couple of numbers, when he could be at home with his family. Council members expressed how they felt it was good PR for someone from the fire department to be here. It didn't have to be him, but they did want someone here who was either a captain or a chief, so they could answer any questions the council may ask. Ald. Hansen explained, this was an agreement with the previous fire chief, when the council donated funds to help the fire department with shift work. Chief Oldebeken stated in that case, he would like the council members to come to the fire board meetings. It was brought to his attention, that, two members of the council were on the fire board, one council member was a fire fighter and others have gone to them. Chief Oldebeken stated, he will inform Recorder/Treasurer Barnes when the monthly fire board meetings will be and she will add them to the announcements. At this time Chief Oldebeken stated again, he was a busy man, and this was just a waste of his time and felt he shouldn't have to be there, nor should any of his fire fighters. Mayor Whitehorn stated he wanted a breakdown of calls as we have had in the past. Ald. Rollins stated she didn't think anyone needed to be here, Ald. Hansen, Ald. Rairdon and Mayor Whitehorn all agreed they would like to see someone here monthly. Majority ruled, it was agreed, an Avoca Fire Chief or Captain needs to be at monthly council meetings.
