6. Events - Rec/Tres. Barnes

- b. Fall Clean-up & Tree Give Away: October 19th: Carroll Electric has volunteered to have an arborist here to instruct residents who get a free tree, how to plant and care for the tree.

c. Trunk R Treat; October 26th: Everything is all ready for this event per Recorder/Treasurer Barnes. School List for Student Hours: Recorder/Treasurer Barnes has been in contact with the Rogers School systems to help local high school kids get their community hours while volunteering at the Avoca events. She has placed flyers around town and on the social media pages to let parents know this.

7. Town Maintenance - Chris Rogers.

Chris let council know the tractor was overheating and is at Springdale Tractor getting fixed.

Committee Reports:

1. Planning commission - Chairmen Alvarenga

- a. Zoning Book: Ald. Alvarenga informed council the planning members finished making changes on the zoning book. Recorder/Treasurer is making these changes, once she is done, she will send the book to town attorney McClure for his input, it will then go back to NWARPC for their final approval. Once they approve it, the book will come before the council to pass it by an ordinance.
- b. The Planning Commission has a new planning member: Rec/Tres. Barnes swore Jordan Dinoffria in on September 17, 2024.

2. Board of Zoning Adjustments- Chairmen Alvarenga

3. Zoning Official – Tim DePue

a. Zoning Official DePue stated he talked to someone at 187 Woods Lodge Road who stated they were in the process of purchasing the home. They were told the property needed to be cleaned up. At this time no clean-up has been done, Zoning Official DePue states the for-sale sign is still up and he will contact the realtor.

4. Streets - Mayor Whitehorn

- a. Old Wire & Tucks Chapel Roads: Mayor Whitehorn stated the resurfacing of these roads have been completed and they will come back later to restripe them.
- b. Dance Road: Ald. Alvarenga states there are tree roots that are tearing up the road. Mayor Whitehorn will contact Franklin Miller about resurfacing that area when he opens Dancer into the new subdivision.

6. Park – Ald. Hansen

- a. Pickleball Court: Ald. Hansens and Recorder/Treasurer Barnes met with Attorney McClure to start the bidding process on this project. Attorney McClure is working on the bid packet.
- b. Wooden Fence Repair/Replace: Options were discussed concerning replacing the wooden rail fences around the parks due to termites. Ald. Hansen will investigate the different options that were discussed: Rot Iron Fencing, Large Rocks/Boulders, Sidewalks, Piping with Cables or Pedestals with Chains.

7. Grants - Ald. Rairdon/Ald. Hansen

Mayor Whitehorn has asked Ald. Rairdon and Ald. Hansen to look into grants for new playground equipment. The equipment in the park we have now needs to be replaced.

8. Animal Control – Ald. Rollins

Ald. Rollins reported she has no current updates.

9. Personnel - Ald. Rairdon/Ald. King

Ald. King states we have a new planning member: Jordan Dinoffria

10. Annexation - Ald. King/Ald. Rollins

Tucks Chapel Road: Ald. King and Ald. Hansen will contact Josh Henderson concerning this issue to get it started.

Old Business

- a. Rose Street Warehouse
 - i. Pursley: Attorney McClure stated he is pursuing this issue and will have an update at the November council meeting.
 - ii. Roof: Mayor Whitehorn informed the council T. Mills Construction has been hired to fix the roof. We are waiting for it to rain to see where the holes are.

b. Tornado Disaster

i. ER*Assist: Recorder/Treasurer Barnes states ER*Assist has been working with FEMA on the town's behalf and all projects are now completed. FEMA states they will pay 75% of damages and the state and other agencies are fighting for them to pay 100% of damages.

c. RR Crossings

- i. Rose Street: Mayor Whitehorn and Recorder/Treasurer Barnes met with ARDOT and the Arkansas Missouri Railroad, there will be gates placed at the railroad crossing on Rose Street. It will take about a year to be placed. This will be paid for through a grant and will be at no cost to the town of Avoca.
- ii. Tucks Chapel Road (crossing over Hwy 62 & Old Wire Road): will be fixed so cars will be able to safely be able to go over it.

New Business

a. Neon Sign: Recorder/Treasurer Barnes informed council the town sign at the food court has a module board out and will need to be repaired. They agreed. The cost is under the mayor's purview, so no motion was needed. Recorder/Treasurer Barnes will contact Best Sign and Banner to have it repaired.

Mayor Whitehorn was asked by Premier Broadband to have council members, recorder/treasurer and himself sign letters of support for them to receive a grant to get fiber out to rural areas around Avoca for residents to get internet. All council members agreed and signed a letter of support.

Council Member Hansen: wanted to make sure Avoca was receiving sales tax from local businesses. She also wanted the town to think of things for the biker to do in town during Bikes Blues and BBQ. She asked the Avoca Fire Chief about fire fighter shifts and getting a rundown of how many days a month are being covered and how much money is being paid out for shift work.

Council Member King: states he will not be available for the town clean-up this year. He also wanted us to know there were four lights out in the park.

Recorder/Treasurer Barnes: asked the council members to let her know all committee dates and who

attended these meetings so she can get them paid in December. She also wanted to let council members know she has had great response about having
