#### **Old Business**

- a. Rose Street Warehouse
  - i Pursley: Attorney McClure states he went to court on February 12, 2025, Mr. Pursley did not show, A body attachment was filed by the Judge. Once picked up, Mr. Pursley will be held, until fines are paid, or payment arrangements are made, depending on what the judge decides to do. Attorney McClure will keep us posted.
- b. Fee Rate Increases Chairman; Ald Aikins
  - i. Ald Aikins informed council a meeting was held on March 4, 2025 concerning raising the rates for fees in the town of Avoca. It was decided to raise the building permit fees, for any new construction, valued at two hundred and fifty thousand dollars (\$250,000.00) or more. The town will charge these fees according to the Benton County building permit fee schedule. Mayor Whitehorn will finalize building permit fees less than two hundred and fifty thousand dollars (\$250,000.00). It was also decided the town would raise the fees for a special meeting from four hundred dollars (\$400.00) to six hundred and eighty dollars (\$680.00) to cover the cost of paying the council/planning/BOA members to attend said meetings. All other fees will remain the same. A resolution will be written and presented to the council at the April 8, 2025 council meeting.

#### **New Business**

- a. Committees
  - i. Paying non-council members: Recorder/Treasurer Barnes asked council if they wanted her to pay non council/planning members who are consultants at committee meetings. Pros and cons were discussed on this issue. No motion was made, issue did not go further/did not pass.
- b. Business Licenses
  - i. Ald. King made a motion to table having outside contractors pay for a yearly business license while doing business inside the town limits of Avoca. No second. Motion died.
- c. Warehouse
  - i. Leased Unlimited Contractors LLC; Mayor Whitehorn informed council members, the warehouse has been rented.
